In compliance with government ordered Conditional Movement Control Order (CMCO) announced on 12 October 2020, **The Malaysian Insurance Institute (MII) customer service counter and library** at the MII City Centre at Wisma FGV, Kuala Lumpur along with our examination centres at **MII City Centre, Kuala Lumpur; Alor Setar, Sandakan, Tawau and Kota Kinabalu will be closed from 14 October 2020 to 27 October 2020.**

Examinations and programmes scheduled to be held at these five (5) centres within the CMCO period will be deferred to a later date and release of results will be deferred to November 2020 onwards. Participants registered for examinations and programmes will be contacted by our team via email and/or telephone on rescheduling arrangements.

During this period, we would like to assure you that we will be operating remotely and remain at your service for any assistance required.
