

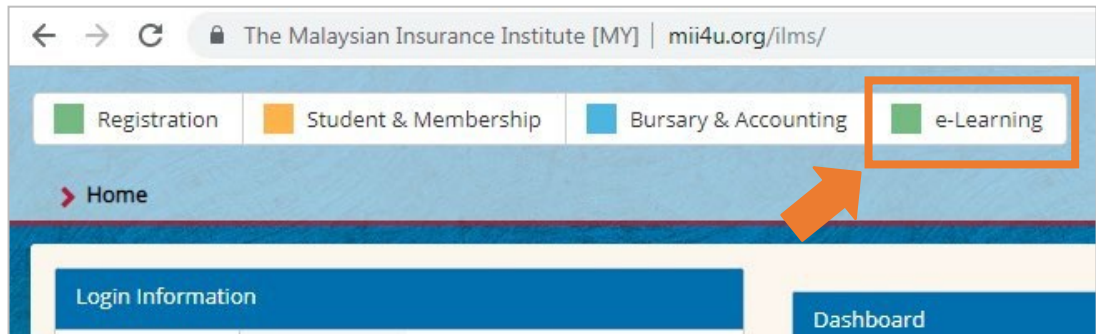

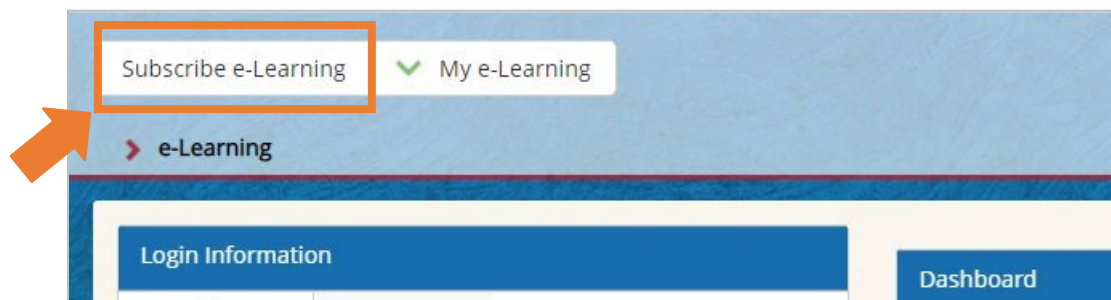
3 Subscribe to Practice Examination

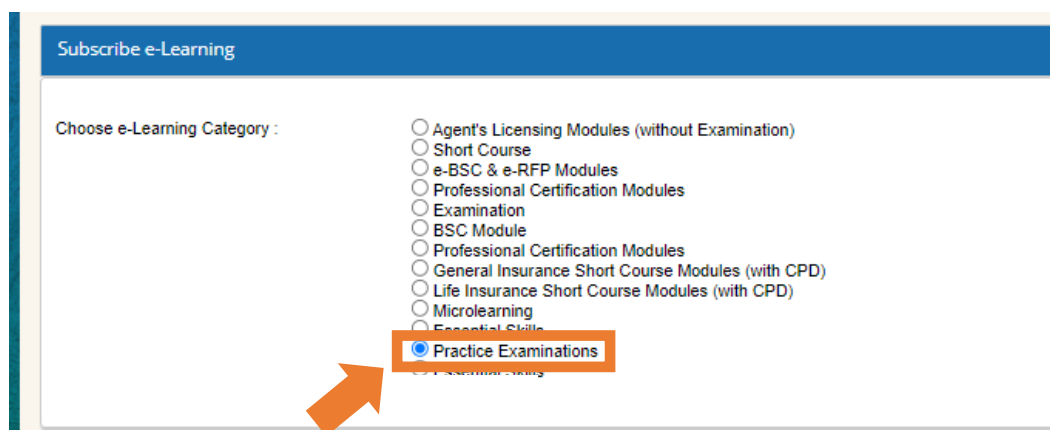
- i. Once successfully logged in, click the **“e-Learning”** button to continue.

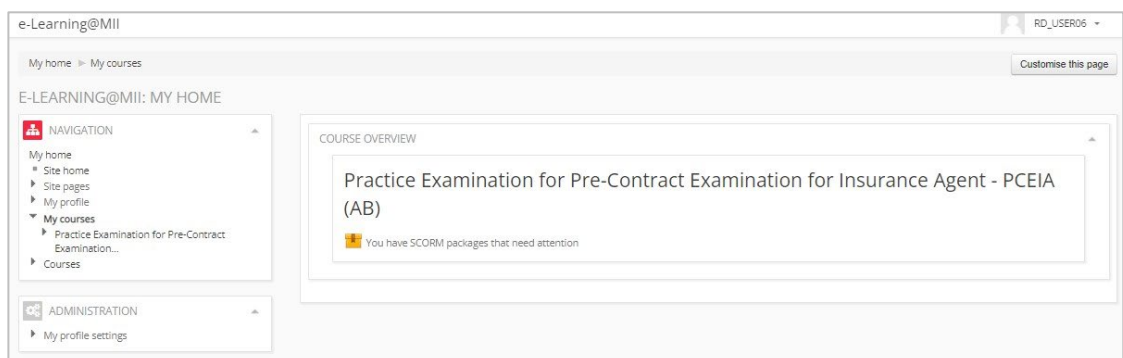
4 View the Practice Examinations

To launch the Practice Examination, please refer to the following steps:

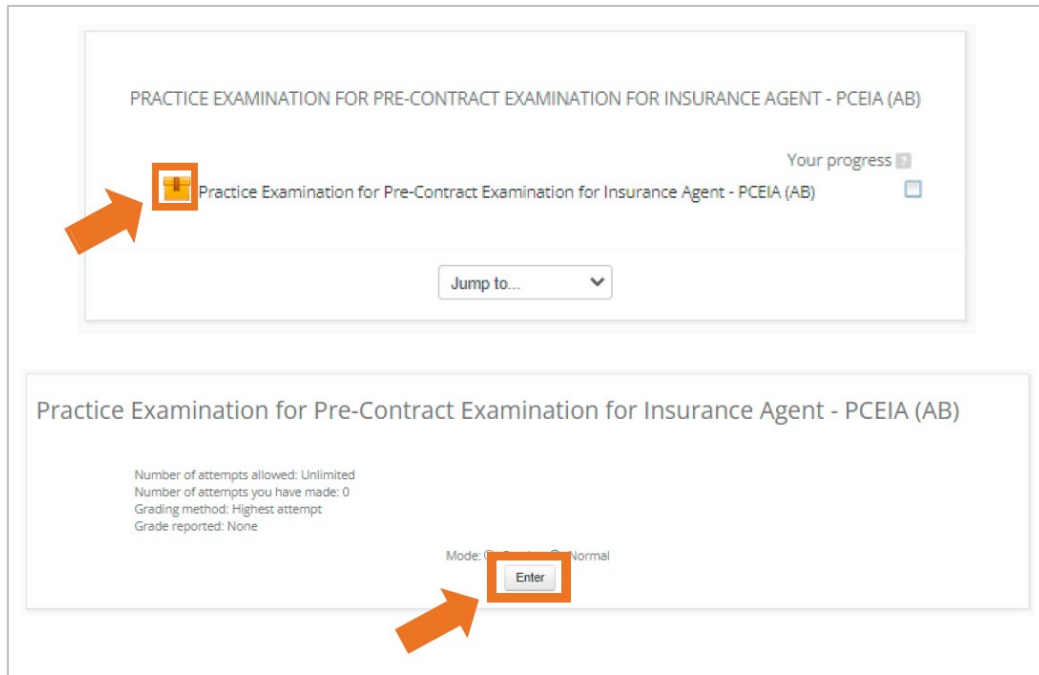
- i. Upon successful subscription and login into iLMS, you will see **"Online Learning Content"** button on your dashboard. Click on the button to proceed.




- ii. Then, you can view the list of your subscribed practice examination. Click on the exam you would like to view.
