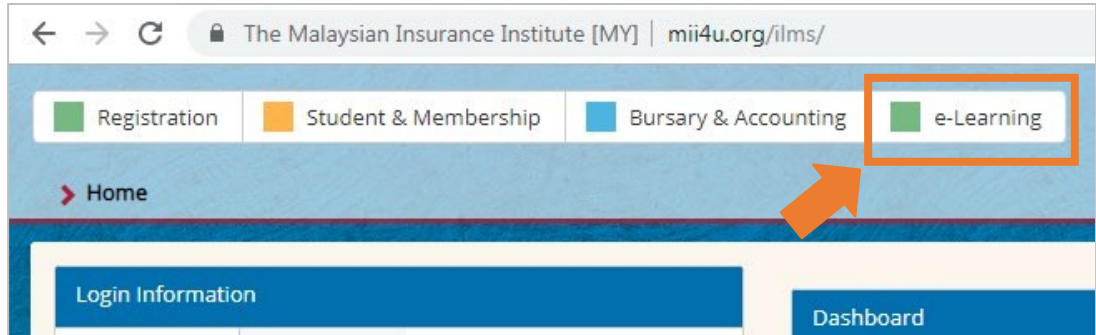
How to subscribe to e-MACC Section 17A module

1	Go to iLMS login page: https://www.mii4u.org/ilms/user/login

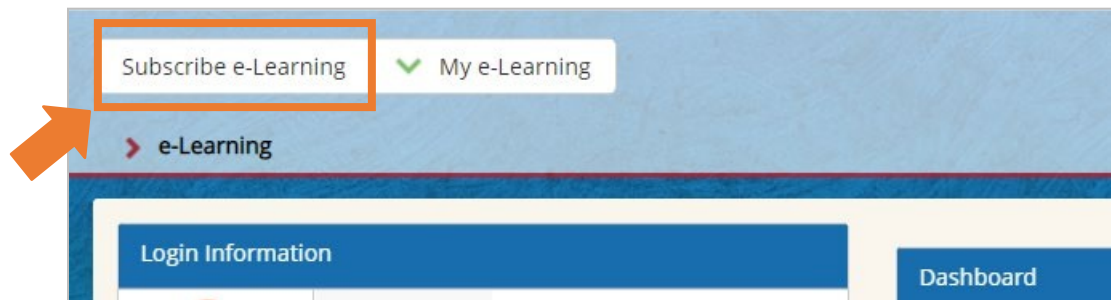
3 Subscribe to e-MACC Section 17A

To subscribe to the e-MACC Section 17A, follow these steps:

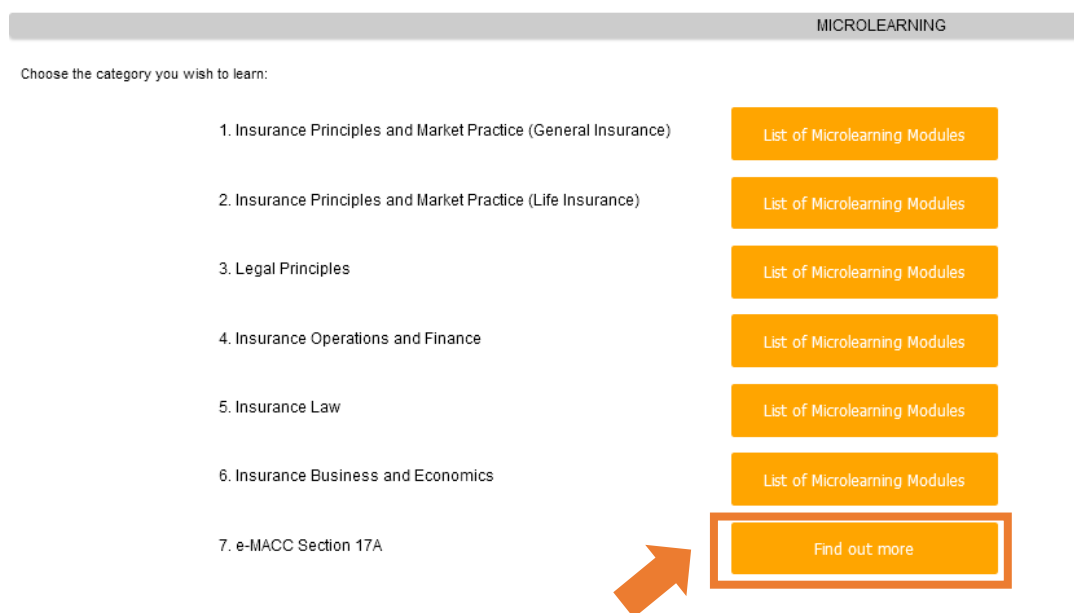
- i. Once successfully logged in, click the **“e-Learning”** button to continue.



- i. Upon successful subscription and login into iLMS, you will see **"Online Learning Content" button** on your dashboard. Click on the button to proceed.
