UPDATE ON NEW MII QUALIFICATION FRAMEWORK – AMII LEVEL 1 & LEVEL 2 EXTENSION ON THE TRANSITION PERIOD

Warmest Greetings from MII.

Reference is made to our announcements dated 25th July 2016 and 18th January 2018 regarding updates and transition period of the MII New Qualification Framework for The Associateship of The Malaysian Insurance Institute (AMII Level 1 and Level 2).

As approved by the MII Academic Council at the 11th MII Academic Council Meeting held on 18th October 2018, we are pleased to inform our all enrolled candidates/students who are currently working towards completing the old MII framework of DMII or AMII are given an extension of another a year from September 2018 examination session to September 2019 examination session to complete their respective programmes under the old MII framework completion requirements.

We would like to bring to your attention that during the transition period :

- 1. to complete the DMII programme (old MII framework), candidates will be required to choose subjects listed under AMII Level 1 only, and
- 2. to complete the AMII programme (old MII framework), candidates will be required to choose subjects under AMII level 2 only.

Thereafter, any candidates who are not able to complete the DMII or AMII programme, the candidates will be transferred to the new framework AMII Level 1 and/or AMII Level 2 to complete their studies. As this is final call, there will be no further consideration for extension of transition period will be given.

Please note that for full completion under AMII New Framework, candidates are required to fulfil a minimum total of 50 credits comprising a total of 18 credits at AMII Level 1 (6 subjects - 3 compulsory subjects and 3 electives subjects) and a total of 32 credits at AMII Level 2 (8 subjects - 2 compulsory subjects and 6 elective subjects).
