**UPDATE ON EXTENSION OF THE TRANSITION PERIOD  
FOR DMII / AMII (OLD FRAMEWORK) STUDENTS**

Warmest Greetings from MII.

Reference is made to our announcement dated 22<sup>nd</sup> October 2018 regarding the approved **extension period** for another a year **from September 2018 examination session to September 2019 examination session** for all our enrolled candidates/students who are currently working towards completing the old framework of DMII or AMII.

During this transition period, the following additional considerations are given to students who enrolled under DMII / AMII only :

1. For students with carry forward coursework marks are allowed to use their coursework marks irrespective of time when the coursework was taken (limit to carry forward for two (2) consecutives examination session within a year period is now lifted)
2. For self-study students, options are given to complete the remaining subjects by taking 100% examination or with carry forward coursework marks of 40%. Students are required to follow the course work submission schedule if option is to have carry forward marks of 40%. (Course work of 40% comprises of 2 tests (10% each) and assignments (20%))
3. Terms and conditions of completion are as per announcement.

After the transition period ends in September 2019, students who are still not able to complete the DMII or AMII programme, the students will be automatically transferred to the current AMII framework. As this is a final call, there will be no further consideration for extension of transition period.
