Mode Of Examination: Computer-Based Examination (CBE)**

In our ongoing quest to support and meet the industry's needs, we are pleased to inform you that we are introducing a new route for licensing examination through a combined Pre-Contract Examination for insurance Agents (PCEIA-Life route) and Certificate Examination in Investment-Linked Life Insurance (CEILLI).

With the introduction of the new examination route entitled Pre-Contract for Life Insurance Agents and Investment-Linked Life Insurance Examination (PCIL), we will have three (3) routes for agents examinations namely:

- Single route option of PCEIA
- Single route option of CEILLI
- Combined route option of PCIL.

The new PCIL examination route will be launched on:

- Monday, 13th January 2020 for the Kuala Lumpur centre and
- Saturday, 18th January 2020 for the outstation centres (as per the CBE schedule)
