International Cyber Threat Task Force (ICTTF) partners with The Malaysian Insurance Institute (MII) to offer Cyber Security Courses in Malaysia.

As cyberattacks rise in frequency and complexity, businesses cannot afford to drop their guard and become complacent.

Kuala Lumpur, 19 July 2022: The ICTTF and The Malaysian Insurance Institute announced a strategic partnership that will provide cyber security training to the insurance industry in Malaysia via ICTTF's Cyber Risk Academy. The Cyber Risk Academy is an online training campus for individuals and organisations to become cyber solid and unified. These courses target all workforce levels, including Malaysia's non-technical, technical, and expert groups.

The Certified Cyber Risk Officer (CCRO), The CCRS - Certified Cyber Risk Specialist and The NCSE (NIST Cyber Security Expert) are among the courses currently offered under this partnership. These courses are further accredited by The International Compliance Association, ICA, which is a long-standing partner with ICTTF and MII.

Paul C Dwyer, President of ICTTF, said, "Our mission is to create a community of cyber good guys working together to defeat cyber evil in all its forms.
